教育職員免許法関係手数料条例を公布する。

This Ordinance on Education Personnel License Act-Related Fees shall be promulgated.

教育職員免許法関係手数料条例

Ordinance on Education Personnel License Act-Related Fees

(通則)

(General Rules)

第一条 地方自治法(昭和二十二年法律第六十七号。以下「自治法」という。)第二百二十七条及び第二百二十八条の規定により、教育職員免許法(昭和二十四年法律第四百四十七号。以下「免許法」という。)に基づく事務に関する手数料をこの条例の定めるところにより徴収する。

Article 1 Pursuant to Articles 227 and 228 of the Local Autonomy Act (Act No. 67 of 1947, hereinafter referred to as “Autonomy Act”), Education Personnel License Act (Act No. 147 of 1949; hereinafter referred to as the “License Act”) shall be collected as provided for in this Ordinance.

(手数料を徴収する事務等)

(Administrative Duties for Collecting Fees, Etc.)

第二条 手数料を徴収する事務並びにその手数料の名称、額及び徴収時期は、別表に定めるところによる。

Article 2 Administrative duties for collecting fees as well as the name, amount and timing of the collection for the fees will be in accordance with the stipulations of the Appended table.

(手数料の減免)

(Reduction and Exemption of Fees)

第三条 前条に規定する手数料は、生活保護法(昭和二十五年法律第四百四十四号)の規定により保護を受ける者から申請があるとき、その他知事において特別の理由があると認めるときは、これを減額し、又は免除することができる。

Article 3 The fees prescribed in the preceding article shall be exempted when an application has been made by a person receiving public assistance under the Public Assistance Act (Act No. 144 of 1950) when another special reason is found to be present by the Governor, fees may be reduced or

exempted.

(手数料の不還付)

(Non-Refunding of Fees)

第四条 既納の手数料は、還付しない。ただし、知事が特別の理由があると認めるときは、この限りでない。

Article 4 Fees that have already been paid will not be refunded. However, this may not apply when a special reason is found to be present by the Governor.

(過料)

(Civil Fines)

第五条 詐欺その他不正の行為により、手数料の徴収を免れた者は、その徴収を免れた金額の五倍に相当する金額(当該五倍に相当する金額が五万円を超えないときは、五万円とする。)以下の過料に処する。

Article 5 A person who has evaded payment of fees using fraud or other wrongful acts is subject to a civil fine not exceeding the amount equivalent to five times the amount evaded (if the amount equivalent to the five times is less than 50,000 yen, the amount of 50,000 yen).

附 則

Supplementary Provisions

1 この条例は、平成十二年四月一日から施行する。

(1) This ordinance will come into effect on April 1, 2000.

2 この条例の規定は、別表に掲げる事務に係る申請の手続で、この条例の施行の日以後に同表の徴収時期に達するものについて適用する。

(2) The provisions of this ordinance will be applied to procedures for applications, etc. pertaining to administrative duties listed in the Appended table that are conducted from the date that this ordinance comes into effect up to the timing of collection in the same table.
