This Ordinance on Licensed Guide Interpreters Act -Related Fees shall be promulgated.

Ordinance on Licensed Guide Interpreters Act -Related Fees

(平一八条例六九・改称)

(Renamed of Ordinance No.69 of 2006)

(通則)

(General Rules)

第一条 地方自治法(昭和二十二年法律第六十七号)第二百二十七条及び第二百二十八条の規定により、通訳案内士法(昭和二十四年法律第二百十号。以下「法」という。)に基づく事務に関する手数料をこの条例の定めるところにより徴収する。

Article 1 Pursuant to Articles 227 and 228 of the Local Autonomy Act (Act No. 67 of 1947, hereinafter referred to as “Autonomy Act”), Licensed Guide Interpreters Act (Act No. 239 of 1949; hereinafter referred to as the “Act”) shall be collected as provided for in this Ordinance.

(手数料を徴収する事務等)

(Administrative Duties for Collecting Fees, Etc.)

第二条 手数料を徴収する事務並びにその手数料の名称、額及び徴収時期は、別表に定めるところによる。

Article 2 Administrative duties for collecting fees as well as the name, amount and timing of the collection for the fees will be in accordance with the stipulations of the Appended table.

(手数料の不還付)

(Non-Refunding of Fees)

第三条 既納の手数料は、還付しない。ただし、知事が特別の理由があると認めるときは、この限りでない。

Article 3 Fees that have already been paid will not be refunded. However, this may not apply when a special reason is found to be present by the Governor.

附 則

Supplementary Provisions

1 この条例は、平成十二年四月一日から施行する。

(1) This ordinance will come into effect on April 1, 2000.

2 この条例の規定は、別表に掲げる事務に係る申請の手続で、この条例の施行の日以後に同表の徴収時期に達するものについて適用する。

(2) The provisions of this ordinance will be applied to procedures for applications, etc. pertaining to administrative duties listed in the Appended table that are conducted from the date that this ordinance comes into effect up to the timing of collection in the same table.
