Ordinance on Securing of Safety and the Optimization of Transaction of Liquefied

Petroleum Gas Act-related Fees

(通則)

(General Rules)

第一条 地方自治法(昭和二十二年法律第六十七号)第二百二十七条及び第二百二十八条の
規定により、液化石油ガスの保安の確保及び取引の適正化に関する法律(昭和四
十二年法律第百四十九号。以下「法」という。)に基づく事務に関する手数料を
この条例の定めるところにより徴収する。

Article 1 Pursuant to Articles 227 and 228 of the Local Autonomy Act (Act No. 67 of 1947,
hereinafter referred to as “Autonomy Act”), Act on the Securing of Safety and the Optimization of
Transaction of Liquefied Petroleum Gas (Act No. 149 of 1967; hereinafter referred to as the “Act”)
shall be collected as provided for in this Ordinance.

(手数料を徴収する事務等)

(Administrative Duties for Collecting Fees, Etc.)

第二条 手数料を徴収する事務並びにその手数料の名称、額及び徴収時期は、別表に定め

るところによる。

Article 2 Administrative duties for collecting fees as well as the name, amount and timing of the collection for the fees will be in accordance with the stipulations of the Appended table.

2 法第三十八条の六第一項の規定により高圧ガス保安協会又は同項の指定試験機関(以下これらを「試験実施機関」という。)が行う液化石油ガス設備士試験を受けようとする者は、別表二十の項に掲げる手数料を当該試験実施機関に納めなければならない。

2 Persons intending to undergo the production safety manager examination or the sales chief examination administered by the High Pressure Gas Safety Institute of Japan or a designated testing agency under Article 31-2, paragraph (1) of the Act (hereinafter collectively referred to as “Test Implementation Agencies”) in accordance with the provisions of the same paragraph must pay the fees set forth in row 20 of the Appended table to the applicable Test Implementation Agencies.

3 前項の規定により試験実施機関に納められた手数料は、当該試験実施機関の収入とする。

3 Fees paid to Test Implementation Agencies in accordance with the provisions of the preceding paragraph shall serve as the revenues of the Test Implementation Agencies.

(手数料の減免)

(Reduction and Exemption of Fees)

第三条 手数料(試験実施機関が行う前条第二項の試験に係る手数料を除く。次条において同じ。)は、知事において特別の理由があると認めるときは、これを減額し、又は免除することができる。

Article 3 Fees (excludes fees pertaining to testing under paragraph (2) of the preceding Article conducted by Test Implementation Agencies; hereinafter the same applies in Article 4) shall be exempted when another special reason is found to be present by the Governor, fees may be reduced or exempted.

(手数料の不還付)

(Non-Refunding of Fees)

第四条 既納の手数料は、還付しない。ただし、知事が特別の理由があると認めるときは、この限りでない。

Article 4 Fees that have already been paid will not be refunded. However, this may not apply when a special reason is found to be present by the Governor.

附 則

Supplementary Provisions

1 この条例は、平成十二年四月一日から施行する。

(1) This ordinance will come into effect on April 1, 2000.

2 この条例の規定は、別表に掲げる事務に係る申請等の手続で、この条例の施行の日以

後に同表の徴収時期に達するものについて適用する。

(2) The provisions of this ordinance will be applied to procedures for applications, etc. pertaining to administrative duties listed in the Appended table that are conducted from the date that this ordinance comes into effect up to the timing of collection in the same table.

This ordinance will come into effect on October 1, 2019. However, the amended provisions under row 14 in the Appended table (limited to the portion in which the “Act on Use of Information and Communications Technology in Administrative Procedure” is revised to the “Act on the Advancement of Government Administration Processes That Use Information and Communications Technology” and “Article 3, paragraph (1)” is revised to “Article 6, paragraph (1)”) will come into effect on the day set forth in the Cabinet Order prescribed in the main text of Article 1 of the Supplementary Provision to the Act on the Partial Amendment of the Acts, Etc. on the Improvement of Convenience of Related Parties Pertaining to Administrative Procedure Based on the Use of Information and Communications Technology and on the Use of Information and Communications Technology in Administrative Procedure for Facilitating Simplification and Enhanced Efficiency of Administrative Operation” (Act No. 16 of 2019).
