宅地建物取引業法等関係手数料条例を公布する。

This Ordinance on the Real Estate Brokerage Act-Related Fees shall be promulgated.

宅地建物取引業法等関係手数料条例

Ordinance on the Real Estate Brokerage Act-Related Fees

(通則)

(General Rules)

第一条 地方自治法(昭和二十二年法律第六十七号)第二百二十七条及び第二百二十八条の 規定により、宅地建物取引業法(昭和二十七年法律第百七十六号)、不動産の鑑定評価に 関する法律(昭和三十八年法律第百五十二号)、積立式宅地建物販売業法(昭和四十六年法 律第百十一号)及び不動産特定共同事業法(平成六年法律第七十七号)に基づく事務に関す る手数料をこの条例の定めるところにより徴収する。

Article 1 Pursuant to Articles 227 and 228 of the Local Autonomy Act (Act No. 67 of 1947), the Real Estate Brokerage Act (Act No. 176 of 1952), Act on Real Estate Appraisal and Evaluation (Act No.152 of 1963), the Act on Real Estate Business Using Real Estate Loans (Act No. 111 of 1971) and the Act on Specified Joint Real Estate Ventures (Act No.77 of 1994) shall be collected as provided for in this Ordinance.

(手数料を徴収する事務等)

(Administrative Duties for Collecting Fees, Etc.)

第二条 手数料を徴収する事務並びにその手数料の名称、額及び徴収時期は、次条に規定 するもののほか、別表に定めるところによる。

Article 2 Administrative duties for collecting fees as well as the name, amount and timing of the collection for the fees will be in accordance with the stipulations of the Appended table, in addition to those provided for in the following Article.

(指定試験機関による試験実施に伴う受験手数料)

(Examination fees for examinations conducted by designated examining body)

- 第三条 宅地建物取引業法第十六条の二第一項の規定による指定を受けた者(以下「指定 試験機関」という。)が行う同法第十六条第一項の宅地建物取引士資格試験を受けよう とする者は、受験申込みの際、受験手数料として八千二百円を当該指定試験機関に納め なければならない。
- Article 3 A person who intends to take the examination for qualification as a registered real estate transaction agent (hereinafter referred to as a "Designated Examining Body".) set forth in Article 16, paragraph (1) of the Building Lots and Buildings Transaction Business Act conducted by a person designated pursuant to Article 16-2, paragraph (1) of the Act shall pay 8,200 yen as an examination fee to said designated examining body upon applying for the examination.
- 2 前項の規定により指定試験機関に納められた受験手数料は、当該指定試験機関の収入 とする。
- 2 Fees paid to designated examining body in accordance with the provisions of the preceding paragraph shall serve as the revenues of the designated examining body.

(Partial amendment of Ordinance No. 158 of 2014, Ordinance No. 33 of 2022)

(手数料の不還付)

(Non-Refunding of Fees)

第四条 既納の手数料は、還付しない。ただし、知事が特別の理由があると認めるとき は、この限りでない。

Article 4 Fees that have already been paid will not be refunded. However, this may not apply when a special reason is found to be present by the Governor.

(徴収の猶予)

(Grace period of collection)

第五条 知事は、特別の理由があると認めるときは、手数料の徴収を猶予することができる。

Article 5 The collection of fees may be grace when a special reason is found to be present by the Governor.

(過料)

(Civil Fine)

- 第六条 詐欺その他不正の行為により、手数料の徴収を免れた者は、その徴収を免れた金額の五倍に相当する金額(当該五倍に相当する金額が五万円を超えないときは、五万円とする。)以下の過料に処する。
- Article 6 The penalty shall be a fine of any person who has been exempted from the collection of fees by fraud or other wrongful act shall be exempted from the collection of fees by a sum equal to 5 times the amount exempted (if the amount equal to 5 times amount does not exceed 50,000

yen, the amount shall be 50,000 yen).

附 則

Supplementary Provisions

- 1 この条例は、平成十二年四月一日から施行する。
- (1) This ordinance will come into effect on April 1, 2000.
- 2 この条例の規定は、別表に掲げる事務に係る申請等の手続で、この条例の施行の日以後に同表の徴収時期に達するものについて適用する。
- (2) The provisions of this ordinance will be applied to procedures for applications, etc. pertaining to administrative duties listed in the Appended table that are conducted from the date that this ordinance comes into effect up to the timing of collection in the same table.
