東京都福祉局関係手数料条例を公布する。

The Tokyo Metropolitan Government Ordinance on Bureau of Social Welfare-Related Fees is hereby promulgated.

Tokyo Metropolitan Government Ordinance on Bureau of Social Welfare-Related Fees

(通則)

(General Rules)

第一条 地方自治法(昭和二十二年法律第六十七号。以下「自治法」という。)第二百二十七条の規定により東京都が徴収する手数料のうち、福祉局が所管する事務に関する手数料は、別に定めがあるもののほか、この条例の定めるところにより徴収する。

Article 1: Unless otherwise provided, the fees to be collected by the Tokyo Metropolitan

Government under the provisions of Article 227 of the Local Autonomy Act (Act No. 67 of

1947; hereinafter referred to as the "Autonomy Act") for matters under the jurisdiction of the

Bureau of Social Welfare shall be collected in accordance with the provisions of this Ordinance.

(手数料を徴収する事務等)

(Procedures for Collecting Fees)

第二条 手数料を徴収する事務並びにその手数料の名称、額及び徴収時期は、別表に定めるところによる。

Article 2: The procedures for collecting fees, designations, amount, and timing of collection shall be as specified in the Attached Table.

(指定試験機関が行う保育士試験に係る手数料)

(Fees Related to Childcare Worker Examination Conducted by the Designated Examining Body)

第三条 児童福祉法(昭和二十二年法律第百六十四号)第十八条の九第一項の規定により、同項の指定試験機関(以下この条において「指定試験機関」という。)が行う保育士試験を受けようとする者は、別表三の項イに規定する保育士試験手数料(以下この条において「試験手数料」という。)を当該指定試験機関に納めなければならない。

Article 3: (1) A person who wishes to take the Childcare Worker Examination conducted by the designated examining body (hereinafter referred to as the "Designated Examining Body") under the provisions of Article 18-9, paragraph (1) of the Child Welfare Act (Act No. 164 of 1947) shall pay the Childcare Worker Examination Fee (hereinafter referred to as the "Examination

Fee") to the Designated Examining Body as set forth in item (a) of Attached Table 3.

2 前項の規定により指定試験機関に納められた試験手数料は、当該指定試験機関の収入とする。

(2) Examination Fees paid to the Designated Examining Body pursuant to the provisions of the preceding paragraph shall be considered as income of said Designated Examining Body.

3 前二項の試験手数料については、第五条から第八条までの規定は、適用しない。

(3) The provisions of Articles 5 to 8 shall not apply to the Examination Fees set forth in the preceding two paragraphs.

(登録試験問題作成機関等が行う介護保険法に係る手数料)

(Fees Related to the Long-Term Care Insurance Act Paid by the Registration Examination Question Preparation Organization)

第四条 介護保険法(平成九年法律第百二十三号。以下この条において「法」という。)第六十九条の十一第一項の規定により、同項の登録試験問題作成機関(以下この条において「登録試験問題作成機関」という。)が作成する試験の問題及び設定する合格の基準を使用して行う法第六十九条の二第一項の介護支援専門員実務研修受講試験を受けようとする者は、別表二の項ヲに規定する介護支援専門員実務研修受講試験問題作成事務手数料を当該登録試験問題作成機関に納めなければならない。

Article 4 Care Insurance Act (Act No. 123 of 1997; hereinafter referred to as “Act” in this Article)
Persons intending to undergo the examination for long-term care support specialist under Article 69-2, paragraph (1) of the Long-Term Care Insurance Act administered using examination questions prepared and criteria for passing established by an organization that prepares registration examination questions under Article 69-11, paragraph (1) of the Act (hereinafter referred to as “Organization that Prepares Registration Examination Questions” in this Article) pursuant to said paragraph must pay the fees for administrative affairs concerning the preparation of examination questions for the examination for long-term care support specialist provided for in the row of (27)-(1) of the Appendix to the applicable Organization that Prepares Registration Examination Questions.

2 法第六十九条の二十七第一項の規定により、同項の指定試験実施機関(以下この条において「指定試験実施機関」という。)が行う介護支援専門員実務研修受講試験を受けようとする者は、別表二の項ワに規定する介護支援専門員実務研修受講試験手数料を当該指定試験実施機関に納めなければならない。

(2) Pursuant to the provisions of Article 69-27, paragraph (1) of the Act, those who wish to take the Nursing Care Support Specialist Practical Training Attendance Examination conducted by the designated examination implementing organization set forth in the same paragraph (hereinafter referred to as the “Designated Examination Implementing Organization” in this Article) shall pay the Nursing Care Support Specialist Practical Training Attendance Examination Fee stipulated in

item (m) of Attached Table 2 to the Designated Examination Implementing Organization.

- 3 法第六十九条の三十三第一項の規定により、同項の指定研修実施機関(以下この条において「指定研修実施機関」という。)が行う法第六十九条の二第一項の介護支援専門員実務研修を受講しようとする者は、別表二の項カに規定する介護支援専門員実務研修受講料を当該指定研修実施機関に納めなければならない。

(3) According to the provisions of Article 69-33, paragraph (1) of the Act, those who wish to take the Nursing Care Support Specialist Practical Training under Article 69-2, paragraph (1) of the Act, conducted by the designated training provider (hereinafter referred to as the "Designated Training Provider" in this Article) shall pay the Nursing Care Support Specialist Practical Training Tuition Fee as specified in item (n) of the Attached Table 2 to the relevant Designated Training Provider.

- 4 指定研修実施機関が行う法第六十九条の八第二項に規定する更新研修(以下「介護支援専門員更新研修」という。)を受講しようとする者は、別表二の項ヨに規定する介護支援専門員更新研修受講料を当該指定研修実施機関に納めなければならない。

(4) Those who wish to take the renewal training prescribed in Article 69-8, paragraph (2) of the Act (hereinafter referred to as "Nursing Care Support Specialist Renewal Training") conducted by the Designated Training Provider shall pay the Nursing Care Support Specialist Renewal Training Tuition Fee prescribed in Attached Table 2, item (o) to the Designated Training Provider.

- 5 前各項の規定により登録試験問題作成機関、指定試験実施機関又は指定研修実施機関に納められた手数料は、当該登録試験問題作成機関、指定試験実施機関又は指定研修実施機関の収入とする。

(5) Fees paid to the Registration Examination Question Preparation Organization, Designated Examination Implementation Organization, or Designated Training Provider pursuant to the provisions of each of the preceding paragraphs shall be considered as the income of the Registration Examination Question Preparation Organization, Designated Examination Implementation Organization, or Designated Training Provider.

- 6 前各項の手数料については、次条から第八条までの規定は、適用しない。

(6) The provisions of the following Article through Article 8 shall not apply to the fees set forth in each of the preceding paragraphs.

(手数料の減免)

(Reduction/Exemption of Fees)

第五条 第二条に規定する手数料は、国若しくは自治法第一条の三に規定する地方公共団体又は生活保護法(昭和二十五年法律第百四十四号)の規定により保護を受ける者から申請があるとき、その他知事において特別の理由があると認めるときは、これを減額し、又は免除することができる。

Article 5: The fees prescribed in Article 2 may be reduced or exempted if an application is made by

the national government, a local government prescribed in Article 1-3 of the Local Autonomy Act or a person receiving public assistance under the Public Assistance Act (Act No. 144 of 1950), or if the governor considers there are other special reasons.

(手数料の不還付)

(Non-refund of Fees)

第六条 既納の手数料は、還付しない。ただし、知事が特別の理由があると認めるときは、この限りでない。

Article 6: Fees that have already been paid shall not be refunded. However, this shall not apply if the governor deems that there is a special reason.

(徴収の猶予)

(Deferral of Collection)

第七条 知事は、特別の理由があると認めるときは、手数料の徴収を猶予することができる。

Article 7: The governor may defer the collection of fees if the governor deems that there is a special reason.

(過料)

(Civil Fine)

第八条 詐欺その他不正の行為により、手数料の徴収を免れた者は、その徴収を免れた金額の五倍に相当する金額(当該五倍に相当する金額が五万円を超えないときは、五万円とする。)以下の過料に処する。

Article 8: A person who has avoided collection of fees due to fraud or other wrongful act shall be punished by the civil fine of an amount equivalent to five times the amount of fee that was avoided (if the amount equivalent to five times does not exceed 50,000 yen, 50,000 yen.)

附 則

Supplementary Provisions

1 この条例は、令和五年七月一日から施行する。

(1) This Ordinance comes into effect as of July 1, 2023.

2 この条例の規定は、別表に掲げる事務に係る申請等の手続で、この条例の施行の日以後に同表の徴収時期に達するものについて適用する。

(2) The provisions of this Ordinance shall apply to procedures for applications, etc. related to the affairs set forth in the Attached Table, whose due date (collection time) prescribed on the same table is on or after the enforcement date of this Ordinance.
