- Loan Limit: 15 million yen (7.5 million yen for working capital only)
- Repayment Period: Up to 10 years (with a grace period of up to 3 years)
- Loan Interest Rate: Fixed interest rate of 2.7% or less
- Guarantor: Corporate representative
- Collateral: Unsecured

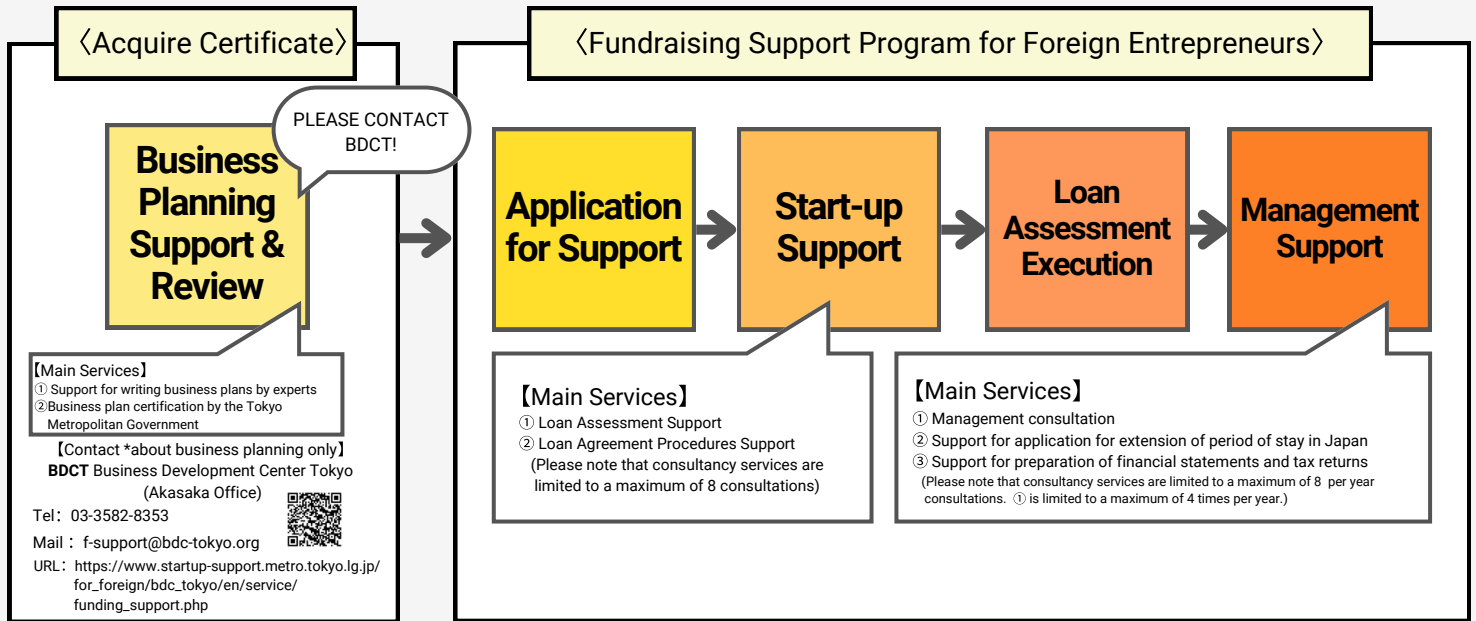

【Principal Requirements for Support Recipients】

- Have a business plan certified by the Tokyo Metropolitan Government
- Less than 5 years from the date of business establishment in Japan
- Possess a status of residence that does not restrict business activities
- Representative of a corporation having its head office or principal office in Tokyo
- The business is a corporation

＜Important Notices＞

- Even if your business plan was certified by the Tokyo Metropolitan Government, if it does not meet the requirements for those who are eligible to get support, set by general support organizations or financial institutions handling your money, you are not allowed to get loan support.
- When you apply for a loan, your application will be examined by the financial institutions handling your money. Depending on examination results, there are cases your loan application may be denied, even if your business plan was certified by the Tokyo Metropolitan Government.
- Loans must not exceed the loan value requested in the business plan certified by the Tokyo Metropolitan Government.
- The business plan may be certified by the Tokyo Metropolitan Government only once.
- Under this program, loans cannot be obtained from more than one financial institution.
- Using the funding to refinance other loans is not permitted.
- This program will be implemented until March 2034.

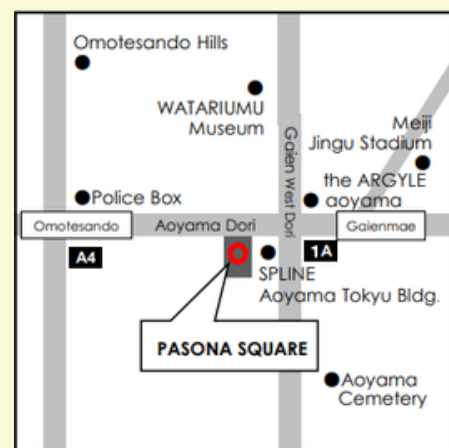
